## MESSAGE FROM THE CHIEF

Welcome to the 2021 Miami Police Department (MPD) Annual Report. In this report, we showcase some of the remarkable work accomplished by our team of men and women. I am proud of our team; they show up ready to respond and serve with respect, dignity, and compassion.

This year, the Department continued to work through the constantly evolving trends of COVID-19. We were able to maintain staffing levels, even while officers were quarantining. Taking proper precautions, we resumed many valued community events and activities such as PAL Football and Cheer, Shop with a Cop, and the Senior Holiday Luncheon. We are excited to be able to participate in these events with members of our community once again. We also hosted the first Pal-loween Haunted House, a not-so-spooky event, for children of all ages.

MPD launched a multitude of new initiatives in 2021. We established the Homeless Empowerment Assistance Team (HEAT) Initiative to aid those in need of homeless assistance. HEAT members coordinate outreach services that enable the homeless community to utilize services they would not seek otherwise. HEAT is an integral piece in reaching those less served and actively assisting with activities such as medical transfers and shelter placements.

MPD also ramped up employee health and wellness professional assistance. The Department increased its volunteer peer mentors to 40, up from 26 in 2020. The Peer Support Program is available for employees who may be going through a difficult time, personal or work related. Peer Support Team members are trained and available to assist their fellow employees, putting in their own time for an important cause. Ultimately, our team's overall well-being is vital to community engagement. Ensuring employee wellness better guarantees improved services to our stakeholders.

In efforts to reduce gun violence, we embarked on a joint mission with Miami-Dade County Police Department and other agencies. We conducted Operations Summer Heat and Community Shield as part of the Gun Violence Reduction Initiative. The initiative's purpose is to use data-driven intelligence that allows our Problem-Solving Teams, Tactical Robbery Unit, and Gangs Unit to investigate and approach offenders most likely to be involved in violent crimes. We also enhanced tracking on all felony arrests involved with gun violence to ensure successful prosecution. While most major cities in the US experienced increases in homicides, I am pleased to report a 25% decrease in homicides in the City of Miami. This is attributed to our partnerships with the FBI, State Attorney's Office, High Intensity Drug Trafficking Areas Task Force (HIDTA), Organized Crime Drug Enforcement Task Force (OCDETF), and a multitude of other co-operational assistance. Our officers make every effort to keep guns, narcotics, and violent offenders off the streets.

Our goals remain to protect and serve as well as restore community trust. This involves a high level of engagement with residents, business owners, and visitors to our City. We aim to provide increased visibility in high-crime areas, targeting hot spots to reduce violent crime, and increase face-to-face contacts. We will continue to instill community policing principles and constitutional policing methods to ensure fair and impartial treatment and protection of citizens' rights.

I look forward to the year ahead. As always, we would not be a successful agency without the support of those we serve. Please know that you, our community, are our top priority. We endeavor to make the Magic City safe for all who live, work, and visit. We can be successful with your continued support!

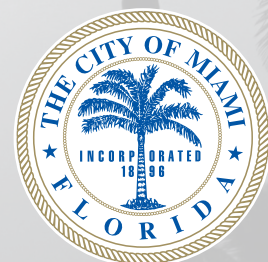

# COVID-19

During 2021, the COVID-19 pandemic continued to impact the City of Miami Police Department. The Health Services Detail under the Personnel Resource Management Section continued experiencing challenges presented by the pandemic due to a substantial increase in employees who were exposed or tested positive to the Delta and Omicron variants. As MPD dealt with its top priority of ensuring that our employees received the necessary medical care, the challenge of doing so, along with employee shortages that were created, kept the Health Services Detail personnel under constant pressure. Additional challenges presented were: The follow-up with our employees to ensure they were provided with proper medical care, ensure that employees who recovered were able to return to work in a timely manner in accordance with Center for Disease Control and Prevention (CDC) guidelines, follow ups on medical advice, and maintain a log for the same.

prolonged medical care. At the time, daily averages were 22 for sworn and two for civilian employees. Nevertheless, as the 2021 holiday season approached, employees increasingly began to report testing positive for the new variant (Omicron). The most significant increases commenced just prior to the Christmas holiday and continued through the New Year where personnel exponentially began testing positive. This substantial spike in numbers resulted in the implementation of new procedures in accordance with the changes proposed in CDC guidelines. Therefore, additional personnel were reallocated to the Health Services Detail to assist in the workload created by the spike in positive cases. The Health Services Detail continues to conduct numerous audits to ensure tracking and accountability for all personnel as it relates to COVID-19 and other health-related needs.



The Health Services Detail at MPD works closely with the City of Miami Human Resources Department, and the Workers' Compensation (WC) claims administrator, USIS, to process the WC claims. Since 2019, procedures have been implemented and modified as needed to ensure an efficient process in the reporting of employee claims, follow ups, and welfare-checks. Prior to December 2021, the detail maintained a minimal number of employees who were significantly affected by the virus who required

The level of enthusiasm and dedication displayed by members of the Detail during these challenging times ensured the safe, efficient, and expeditious return of our personnel.




# CHIEF CLARENCE DICKSON POLICE COLLEGE

On March 23, 2021, the Miami Police Department Training Center was re-named in honor of former Chief Clarence Dickson. Clarence Dickson joined MPD in 1960. He was one of three African-Americans allowed to attend the Miami Police Academy, the only one who graduated, and the first black man to do so. He rose through the ranks, ultimately becoming the first African-American police chief in 1985.

Wearing his signature cowboy hat, Chief Dickson accepted the honor with gratitude. He addressed the gathering speaking about his journey and struggle as a black man in the then segregated Miami Police Department. The Chief Clarence Dickson Police College bears his name in his honor for his numerous lessons and contributions to MPD. His leadership and tenacity continue to pave the way for many officers today.

## AUBREY JOHNSON, JR. AUDITORIUM

On July 9, 2021, "Beyond the Call of Duty" End of Watch Ride to Remember visited the City of Miami to honor one of our fallen officers Aubrey Johnson, Jr. who passed away on October 1, 2020. This organization visits police agencies throughout the country that have lost officers in the line of duty. Spokesman and founder of "Beyond the Call of Duty" Jagrut Shah, a former deputy sheriff, says the organization wants to show departments and their families who have lost partners and friends they are not alone. Shah states, "I wanted to bridge this gap that

we have and bring back to the department and let the officers and their families know that their loss has not been forgotten."

Additionally, on that same day the Miami Police Training Unit honored our beloved Aubrey Johnson, Jr. by placing a dedication plate with his name on the doors of the police auditorium. Officer Aubrey Johnson, Jr. and his family will never be forgotten by the MPD family.



# STOP THE SILENCE AGAINST GUN VIOLENCE PEACE MARCH



On June 16, 2021, the City of Miami Police Department alongside Crystal Foster of "We Stand 4 Justice Inc." and several other law enforcement agencies hosted the Stop the Silence Against Gun Violence Peace March. The march served as a conduit to spread awareness and to call on the community to help put an end to gun violence and encourage community members to say something if they see something regarding gun violence incidents. The organizers wanted a call to action since the early part of 2021 saw increasing gun violence in Miami-Dade

County, with many victims being innocent children caught in the crossfire. Spanning one and a half miles, the march started at Ark of The City and ended at Range Park with several guest speakers. Community members, Mayor Francis Suarez, Mayor Daniella Levine Cava, Commissioners Keon Hardemon and Jeffrey Watson, members of the MPD, Miami-Dade Police Department, and Miami Gardens Police Department walked the route in the rain with resolve that together we can make an impact in reducing gun violence.

# SOS CUBA PROTESTS

In July 2021, a series of protests by those living in Cuba against the Cuban government based on shortages of food, COVID-19 vaccines, and other medicines triggered protests and demonstrations of support in Miami and all over the world. For several weeks, peaceful protesters gathered, marched, and arranged concerts to bring attention to the inhumane treatment of residents in

Cuba. The mottos SOS Cuba and Patria Y Vida (Homeland and Life) were utilized as a call to freedom and for humanitarian aid. Throughout the month of July, the Miami Police Department monitored the protests and concert events to keep both protestors, pedestrians, and drivers safe during the demonstrations.



# 20TH ANNIVERSARY OF 9/11



On September 1, 2021, celebrating the 20th anniversary of 9/11, the Miami Police Department unveiled MPD's 9/11 Remembrance vehicle. In honor and remembrance of all the brave first responders and civilians who laid down their lives to save others on September 11, 2001, the Community Police Relations Foundation (CPRF) donated the vehicle wrap. Culminating this event, a check was presented to the Tunnel to Towers Foundation

with proceeds collected during the sale of our 20th Anniversary 9/11 Remembrance Badge. Retired Fire Department of New York Battalion Commander Jack Oehm addressed those at that event and spoke about the harrowing events of 9/11 and the valiant efforts to support and honor veterans, first responders, and their families through the Tunnel to Towers Foundation.



# COMMUNITY RELATIONS HIGHLIGHTS

The Community Relations Section strives to bring different and unique events for our community to enjoy creating strong relationships between MPD and our residents, businesses, and visitors. This year, two events, PAL-loween and the United First Responders Music Festival, stand out as particularly momentous as they provided safe ways for our community to come together amid COVID-19. On October 28, 2021, held at Central Station, PAL-loween saw the advent of our first "Not So Spooky Haunted House," and included activities such as movies, Trunk-or-Treat, costume contest, and more.

On November 20, 2021, the United First Responders Music Festival occurred at Regatta Park. Bands comprised of police officers and firefighters from Puerto Rico, Dallas, New Jersey, New York, Homeland Security, Collier County Sheriff's Office, Broward Sheriff's Office, Miami-Dade County, and MPD's In Blue Band performed for the community. The event also included food trucks, police and fire expo, a kid rock zone, a motorcycle and Jeep show, and a touching tribute by the Calvary Chapel Choir to first responders who worked at the Champlain Towers collapse site in Surfside.





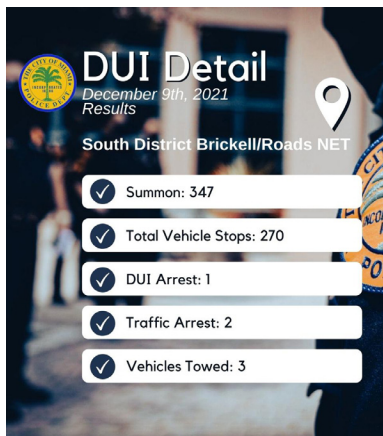
# SOCIAL MEDIA SPOTLIGHT

The Social Media Detail continued to create content to assist the department throughout the year. Types of material created and issued for the public were information posts and content related to recruitment and community relations activities, social media-based tutorials, and Do the Right Thing Program video productions. The Detail also created training videos and internal social media content for MPD.

Members of the Detail published over 1,390 Twitter posts with over 13,790,000 views, 48 Nextdoor posts with over 39,100 views, and over 460 Facebook posts. The Detail also published over 437 posts on Instagram and gained 8,000 new followers. Nineteen videos were published to the MPD YouTube channel, which included patrol and training vlogs, virtual ceremonies, and recruitment efforts. Videos included an officer's first day patrolling Model City, female imminent response

strategies and tactics, patrolling Art Basel, patrolling the Little Havana neighborhood, and patrolling with K-9. The YouTube channel received over 2,609,000 views and gained over 6,600 new followers. In efforts to reach a younger demographic, the Detail created a TikTok channel.

In October, when the Social Media Detail released a recruitment video that went viral, MPD received national acclaim. In typical Miami style, the video is set to a club remix of Rick Astley's, "Never Gonna Give You Up" and highlights various units within MPD. The high-energy video encourages viewers to apply to become a police officer and features community member testimonials about MPD officers. The video superseded all expectations and within hours the recruitment process was closed with MPD receiving 1,000 applications during that time.



The Public Information Office (PIO), Special Projects Management Unit (SPMU), Strategic Planning and Performance Unit, and Internal Affairs & Professional Compliance Section (IA/PCS) fall under the purview of the Office of the Chief. Each of these is vital to the organization for a myriad of functions.

## Public Information Office

In 2021, the Public Information Office played a vital role in disseminating information to the news media and public on all issues involving public interests, safety or concerns including numerous protests throughout different parts of the city.

- Responded to 52 active crime scenes, some of which were in-progress, to disseminate accurate and complete information
- Disseminated 450 news releases
- Handled approximately 800 media inquiries, calls for service information, media ride-along requests and requests for interviews with the Chief of Police including talk shows via phone, virtual, radio, and television
- Fulfilled over 100 media records requests
- Clipped and archived over 1,000 media broadcasts, news articles
- Reviewed approximately 125 award nominations and distributed over 200 awards, including, civilian community awards
- Coordinated and assisted in 17 news conferences including safety measures of community interest, specialized vehicle unveilings, and charitable donation announcements

## Social Media Detail

The Social Media Detail played a vital role in disseminating information to the public on a local and national level to include traffic alerts, safety tips, crime alerts, ceremonies, promotions, community events and departmental initiatives that showcase and recognize the department's achievements.

## Chaplaincy Corps

The Chaplaincy Corps remains an essential provider of pastoral care and support to members of the department on issues such as bereavement, trauma, and counseling. The Chaplaincy Corps includes ten members of different faiths who participate in the department's award ceremonies, promotional ceremonies and Police Academy ceremonies as needed. They are on call 24/7 for the needs of the department, attend monthly roll calls, participate in patrol ride-alongs, and visit different units for prayer and/or counseling as needed. The chaplains continue to be a valuable resource in the support of multi-faith for those seeking their services.

## Special Projects Management Unit

- Managed over 40 projects budgeted over \$15 million. The projects include grant-funded initiatives as well as large-scale department-wide projects to ensure on-time and on-budget deliverables for MPD.
- Coordinated Summer Jobs Connect Program with youth working remotely in conjunction with City of Miami's Office of Grants Administration and the Overtown Youth Center for the second consecutive year.

Under the direction of **Assistant Chief Thomas Carroll**, the Administration Division is comprised of the following sections: Business Management, Information Technology Support, Training, and Personnel Development, Personnel Resource Management, Communications/Support Services, and the Property and Evidence Management Sections. These sections manage financial responsibilities, human resources functions, and provide support in the operation and administration of the Department.

This program allows the public to stream live video to the Communications Center, officers on a scene, and detectives to provide updated information and receive more effective police services.

This upgrade provides agencies the ability to work more efficiently on cross jurisdictional incidents which benefits the public and increases officer safety.

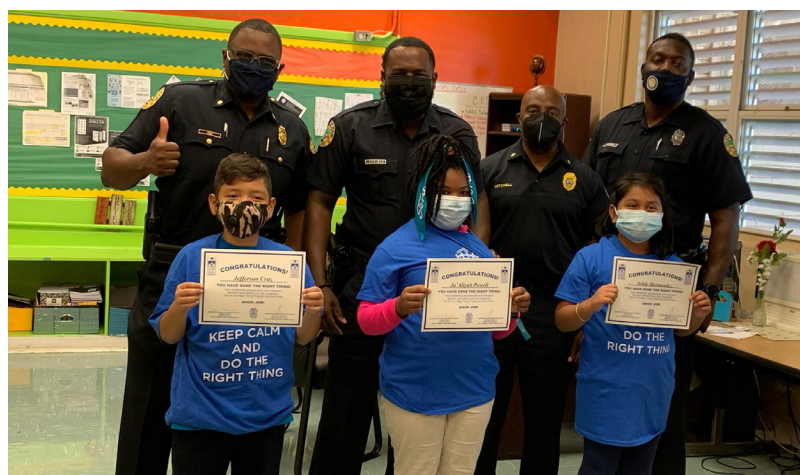

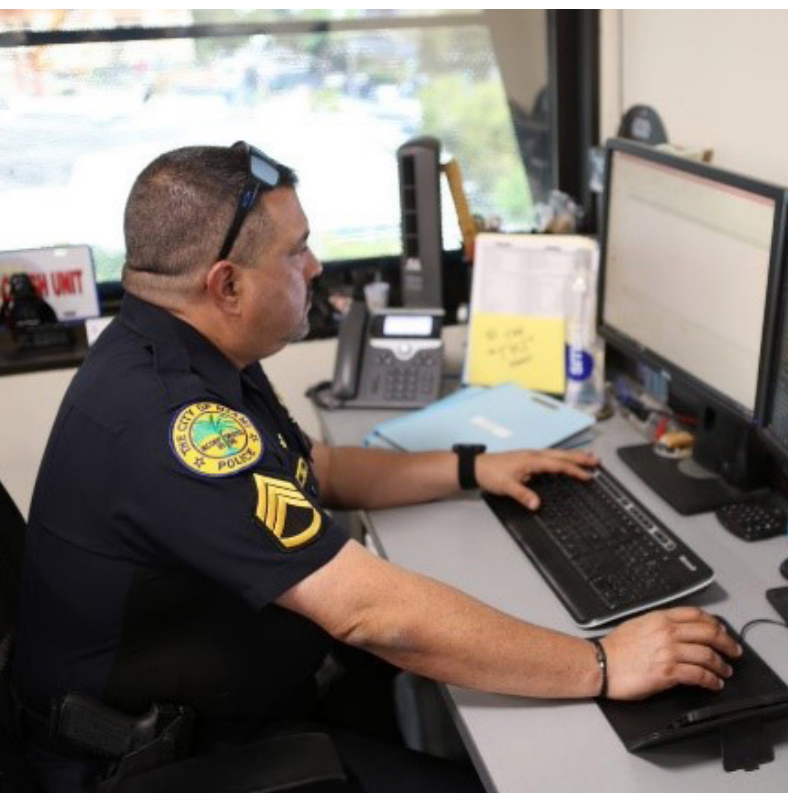

Locations selected based on ongoing issues that may be occurring and complaints received.

- Facilitated a Chief for the Day Experience for TJ Mack. On October 15, the 5-year-old was celebrated as police chief; he toured the City of Miami, visited the aquarium, met members of the Miami Dolphins team, and rode in the police helicopter.
- Hosted the first Pal-loween event featuring a not-so-scary Haunted House, movie, and other activities
- Graduated six Citizens on Patrol Police Academy Classes
- Conducted a Gun Safety Awareness Course
- Added a full-time LGBTQ+ liaison officer to better serve and educate the community and unveiled the first LGBTQ+ vehicle
- Hosted six Dedication 2 Community sessions, three of which were in the community collaborating with the Miami Heat
- Launched Cultural Awareness Relationship Enrichment (CARE) Workshop



### **Youth Involvement Unit /Police Athletic League (PAL)**

- Hosted over 350 youth participants for tackle football and cheer programs, 50 participants for track and field, and 60 participants for summer camp
- Mentored over 150 children through Science, Technology, Engineering, Arts, and Mathematics (STEAM) Program
- Facilitated the Gang Resistance Education And Training

## FIELD OPERATIONS DIVISION (cont'd.)



- (GREAT) Program in schools, graduating nine participants
- Chaperoned 60 summer camp youth participants to Kennedy Space Center
- Held the first Explorer Summer Academy at the Chief Clarence Dickson Police College
- Hosted Teen Talks sessions in all three districts

### Do The Right Thing Program (DTRT)

- DTRT recognized and rewarded 5,312 students who each received a t-shirt, certificate, and congratulatory letter from the Chief of Police, bumper sticker, Papa John's pizza, and two tickets to the Miami Marlins baseball game.
- DTRT's Officer Do Right initiative assigns a MPD police officer to personally visit select schools each month to award nominees and have lunch with them. In 2021, eight MPD officers participated in the Officer Do Right initiative at 29 City of Miami elementary schools and

- shared a McDonald's Happy Meal lunch with 1,004 students.
- DTRT's Cop Stop Teen Training has officers teach students what to expect during a traffic stop. MPD officers conducted the training to 90 Miami Senior High and Booker T. Washington Senior High 11th Graders.
- DTRT awards the Angel Calzadilla Scholarship in honor of former MPD officer Angel Calzadilla. This year, Jamareh Davis was awarded \$6,100 to begin his law enforcement career at the Miami Police Academy.
- The Summer Citation initiative involves the City of Miami's Neighborhood Resource Officers issuing free Papa John's pizza "citations" to kids they spot doing the right thing in the community, ensuring continued positive engagement with youth while students are out of school. In the summer of 2021, 300 free pizza citations were distributed by MPD officers throughout Miami to children caught doing the right thing in the community.

# CRIMINAL INVESTIGATIONS DIVISION



The Criminal Investigations Division (CID) commanded by **Assistant Chief Armando Aguilar** includes three sections: Criminal Investigations Section (CIS), Investigative Support Section (ISS), and Special Investigations Section (SIS). CIS is tasked with investigating and following up on leads of investigations assigned to the section. ISS provides analysis, technical investigative support, information and intelligence, and a tactical response to assist all the elements of the CID and the FOD. SIS conducts investigations into illegal narcotics activity, illicit transportation of US currency and money laundering, terrorists, and organized crime activity. Additionally, the Section provides dignitary protection.

## Criminal Investigations Section

CIS comprises the following units: Homicide Unit, Assault Unit, Robbery Unit, Special Victims Unit, Domestic Violence Unit, General Investigations Unit, and the Victim Advocate Services Unit.

- Investigated 211 sexual batteries
- Cleared 99 sexual battery cases
- Assisted in the recovery of 287 missing persons
- Investigated 372 cases referred by the Department of Children and Families

### Homicide Unit

The Homicide Unit is dedicated to investigating homicides, suicides, accidental deaths, natural deaths, and unclassified deaths.

- Investigated 47 murders
- Cleared 22 murders and secured five arrest warrants
- Investigated 1,186 manslaughters and non-criminal homicides, suicides, accidental deaths, natural deaths, and unclassified deaths
- Closed a 2019 cold case through DNA evidence

### Assault Unit

The Assault Unit investigates violent crimes, including but not limited to attempted murder, aggravated battery, aggravated assault, and aggravated stalking.

- Investigated 750 violent crimes
- Cleared 174 cases

### Robbery Unit

The Robbery Unit's primary function is to investigate robberies, kidnappings, and extortions.

- Investigated 508 cases
- Cleared 238 cases
- Secured 21 federal indictments for armed violent offenders

### Special Victims Unit

The Special Victims Unit (SVU) consists of Sexual Battery, SVU Cold Case, Internet Crimes Against Children (ICAC), and Missing Persons/Department of Children and Families Details.



### Domestic Violence Unit

The Domestic Violence Unit investigates all domestic violence incidents, including dating violence.

- Investigated 1,387 domestic violence cases
- Cleared 746 cases

### General Investigations Unit

The General Investigations Unit includes the Burglary, Auto Crimes, Economic Crimes, Pawn Shop, and Squatter Details.

### Burglary Detail

- Investigated 1,397 burglaries

- Cleared 208 burglary cases
- Closed multiple cases with the arrest of four suspects who drugged their victims and stole their valuables

### **Auto Crimes Detail**

- Investigated 518 fraud and economic crimes

### **Pawn Shop Detail**

- Received 23,197 Pawnbroker Transaction Forms
- Checked 1,892 pawned firearms
- Arrested 14 suspects for firearm violations and dealing in stolen property

### **Squatter Detail**

- Investigated 12 squatter complaints
- Conducted five squatter removals, referred four cases to civil courts, and three occupants voluntarily vacated the premises

### **Victim Advocate Services**

Victim Advocate Services provides personalized and professional assistance to any person who has suffered, directly or indirectly, a physical, emotional, or personal loss because of a criminal act. This assistance includes notifying victims of their legal rights, remedies, and victim's compensation benefits, responding to incident scenes when requested, and providing referrals to community agencies.

- Assisted 7,217 victims of crime
- Victim/Witnesses relocated:
  - Assisted two victims in the Victim/Witness Relocation (VWR) Program
  - Temporarily relocated five victims to hotels
- Assisted with applications for 150 Immigration U-Visas for victims of crime

## **Investigative Support Section**

ISS is comprised of three Units: Investigative Intelligence Unit (IIU), Tactical Investigations Unit (TIU), and Crime Scene Investigations Unit (CSI).

### **Investigative Intelligence Unit**

IIU is made up of the following details: Real Time Crime Center (RTCC), Criminal Intelligence, Crime Analysis,

Criminal Intelligence Analyst, Computer Forensic, Technical Assistance, Crime Gun Intelligence, and Video Retrieval.

### **Real Time Crime Center**

RTCC's mission is to provide 24/7 real-time actionable information, thereby enhancing situational awareness and creating a "virtual arrival" scenario for officers responding to priority service calls, developing situations, and critical incidents.

- Added 102 public safety cameras, increasing the number of cameras from 435 to 537
- Assisted in launching an offsite office for the City of Miami Solid Waste Department for the 24/7 monitoring of illegal dumping throughout the City
- Enhanced our public safety capabilities through public and private partnerships with the Wynwood and Coconut Grove Business Improvement Districts (BID), the Design District, Ring Law Enforcement Portal, Florida Department of Transportation, University of Miami Hospital, and others
- Enhanced our technological capabilities to monitor social media threats, geo-locate 911 callers, perform video analytics, and integrate RTCC functions into a cloud environment
- Expanded CCTV trailer fleet from 10 to 22
- Assisted in the arrests of 71 suspects with the use of CCTV cameras

### **Criminal Intelligence Detail & Criminal Intelligence Analyst Detail**

The Criminal Intelligence Detail and Criminal Intelligence Analyst Detail assist investigative units in locating and providing criminal intelligence, leading to the identification and arrest of subjects.

### **Criminal Intelligence Detail**

- Conducted 322 facial recognition searches
- Conducted 418 social media searches
- Disseminated 391 Crime Stoppers tips

### **Criminal Intelligence Analyst Detail**

- Processed 2,259 requests
- Checked 14,395 resources

### **Crime Analyst Detail**

The Crime Analyst Detail analyzes calls for service and crime incident report data to identify patterns in concentrated areas, trends, and modus operandi targeted by patrol officers and investigative units. The Crime Analyst Detail also works closely with neighboring

local, state, and federal agencies to ensure pertinent information is disseminated in a collaborative effort to apprehend potential offenders. In addition, the detail is responsible for developing and maintaining a comprehensive analysis system.

- Partnered with the University of Chicago and the Policing Lab to innovate analytical strategies and quantitative methodologies

## **Domestic Violence Apprehension Team**

Created in March of 2021, The Domestic Violence Apprehension Team apprehends subjects who are wanted for felony domestic violence cases.

## **Crime Scene Investigations Unit**

CSI is comprised of the Crime Scene Detail and the Technical Services Detail. The Technical Services Detail functions include the Latent Prints, Employee ID, and the Photo Lab.

## **Crime Scene Detail**

- Acquired the Recover platform to obtain fingerprint evidence from spent shell casings and other metallic surfaces
- Certified four Crime Scene Investigators through the International Association of Identification
- Processed over 700 firearms for latent fingerprints and DNA

- Produced 230 photo identifications for vendors, sworn Police, and civilian City of Miami personnel
- Fingerprinted 197 sworn and civilian public persons for various licenses, applications, record expungements, etc.

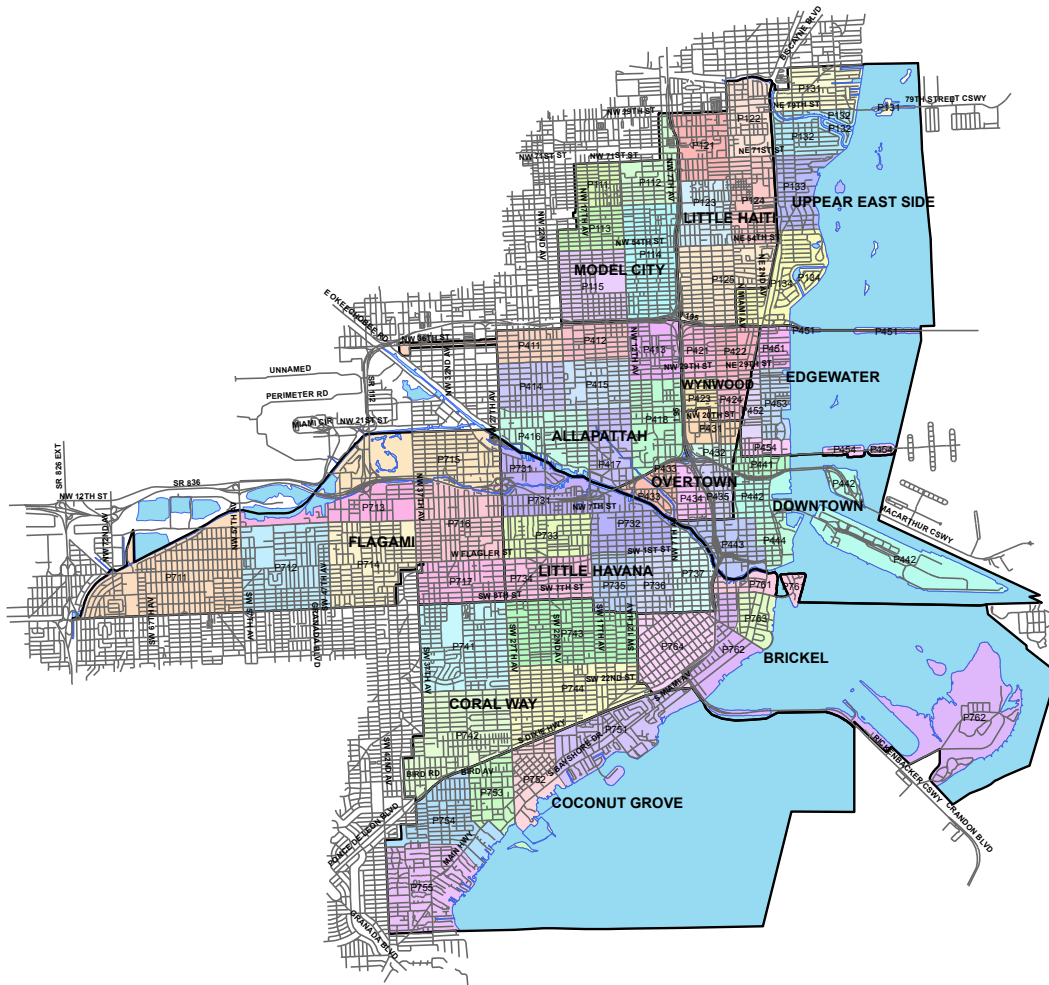

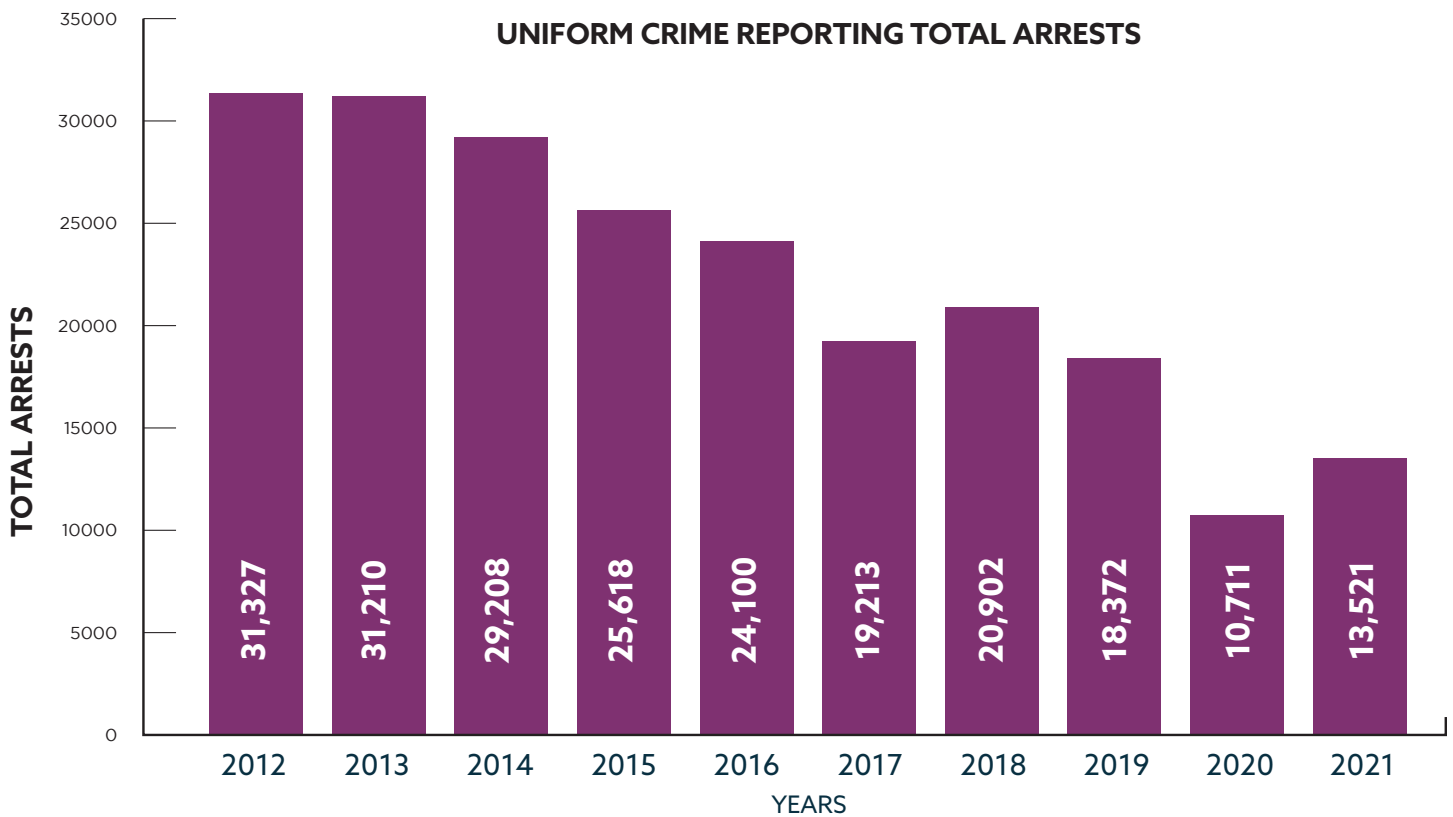
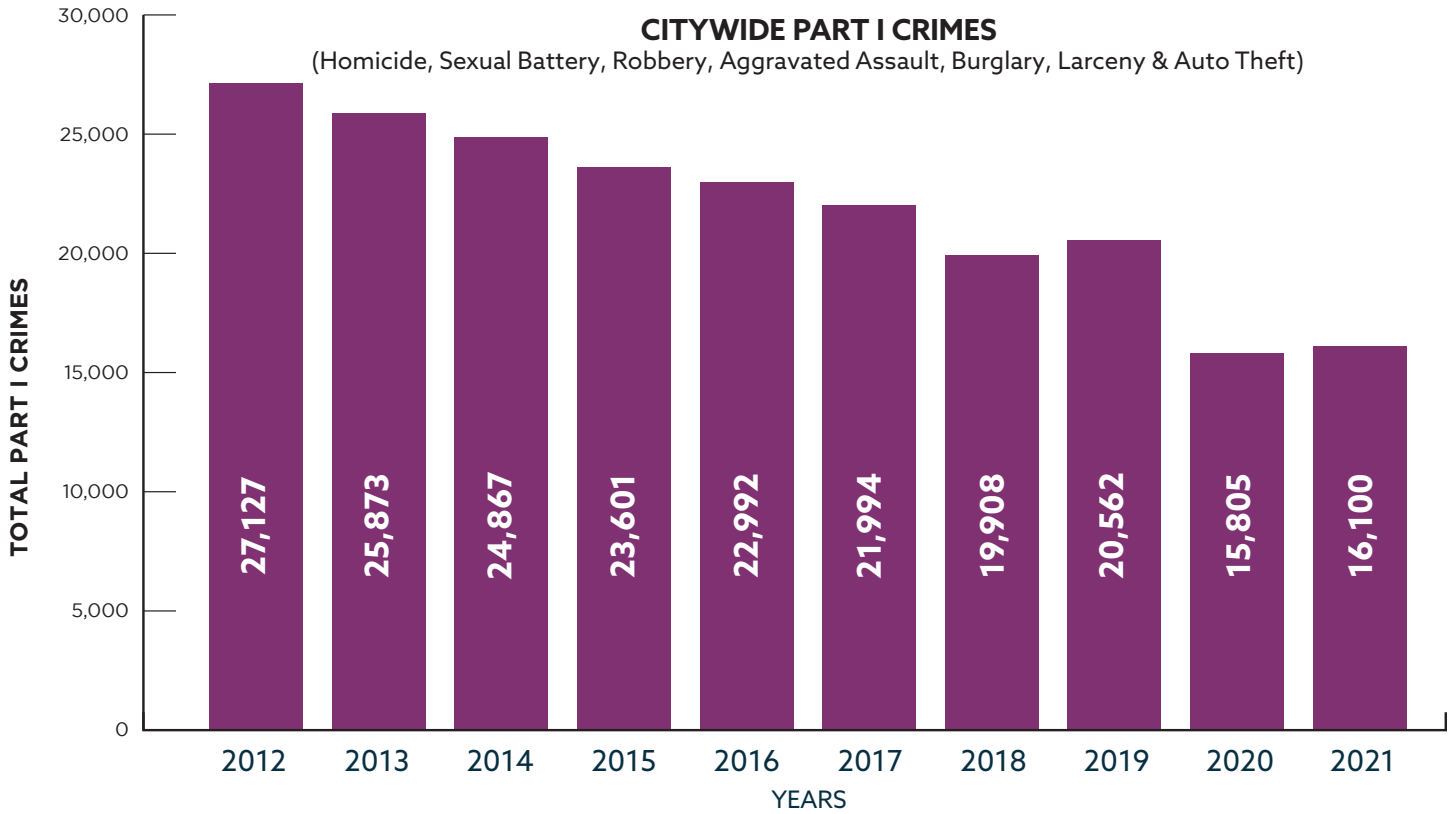
