## SERIAL BURGLAR APPREHENDED

In a combined effort with Miami Police Burglary Detectives, Downtown, and Brickell-Roads Problem Solving Teams, a serial burglar was apprehended. **David Theoder Sharon**, **D.O.B. 06/21/1958** was successfully located and charged for committing multiple burglaries within a short time span in the City of Miami's jurisdiction, including locations such as the Frost Museum, the Four Seasons Hotel and Luxury High Rise Condominiums.

On March 30, 2020, the subject burglarized two vending machines located at 1501 Biscayne Blvd, causing \$6,000.00 each in damages and making off with \$250.00 in total.

On April 5, 2020, a burglary was reported at 460 N.E. 28 Street where the subject burglarized a vending machine causing \$8,500.00 in damages and stealing \$200.00 from inside.

On April 22, 2020, the subject burglarized a building located at 999 Brickell Avenue causing \$500.00 in damages. The subject then proceeded to the vending machine where he then caused \$4,000.00 in damages and steals \$150.00.

On April 24, 2020, the subject was captured on surveillance footage on the premises of Chase Bank, located at 150 S.E. 2 Avenue using a crowbar to pry open the locked door to the parking garage. The subject proceeded to vandalize a vending machine, causing \$300.00 in damages. As a result the subject managed to steal approximately \$100.00 in cash.

On April 26, 2020, a burglary was reported at a Luxury High Rise Condominium, located at 1200 Brickell Bay Drive. The same offender is seen vandalizing a vending machine with a metal object, resulting in him making off with \$5.00 in change.

On April 27, 2020, the subject can be seen on surveillance vandalizing a steel security door to gain entry to the westside of the loading dock located at 270 Biscayne Blvd. Once inside, the subject makes his way to the vending machine where he steals both money and food from inside.

On April 29, 2020, the subject was captured on video surveillance using a crowbar to vandalize yet another vending machine at the Four Seasons Hotel, located at 1435 Brickell Ave. Later this same day, the subject burglarized a business located at 13 S.W. 7 Street and stole several boxes of cigarettes, totaling approximately \$969.00.

On May 10, 2020, the subject was captured on surveillance using a crowbar to pry open an ATM Machine located at the Frost Museum (1100 Biscayne Blvd). Minutes later, the subject walks over to the gift shop area of the museum and takes three bottles of water, a black bookbag and 120 pieces of metal jewelry, totaling over \$1,000.00.

Note: the same offender has been charged for his involvement in burglaries outside of our jurisdiction as well.
