Beginning at 7 a.m. Wednesday, July 29, 2009, the Region 7 Southeast Regional Domestic Security Task Force (SERDSTF), comprised of Palm Beach, Broward, Miami-Dade and Monroe County agencies will participate in training exercise <u>OPERATION</u>

<u>CASSANDRA</u>. The objective of the event will be to test the region's resources, response and capabilities to mitigate a **SIMULATED** threat by a **FICTITIOUS** terrorist group directed at multiple locations simultaneously throughout South Florida.

Participating entities from their respective counties will exercise components of their infrastructure to include law enforcement, medical, fire, transit, education and emergency operations centers.

While there is no planned disruption of traffic related to this exercise, there will be a visible presence of law enforcement, fire-rescue and numerous emergency responders from Marathon to West Palm Beach. The media are invited to observe the operation from selected scenario venues within the four-county region. Interested media should report to any of staging areas indicated below and check in with the lead PIO. A participating agency PIO will escort the media to areas of the exercise that are not intelligence- sensitive.
